On Tuesday March 4th, 2025 in the Meeting Room at the Floyd Mitchell Chickasaw Landfill at 5:30 p.m. the regular meeting of the Executive Board of the Floyd Mitchell Chickasaw Solid Waste Management Agency was held in person and by Zoom.

Chairman Scott Cerwinski, was in the chair. Executive Board members Sydney Hartogh, Dave Swenumson, Steve Geerts, Dennis Keifer, Trevis O'Connell and Keith Horgen were in the Boardroom. Absent: Jerry Joerger and Brock Waters.

Employees Present: Christian Fox, Director.

Guests Present: None

A motion was made by Keifer, second by Hartogh to approve the consent agenda, minutes from the November 2024 Executive Board Meeting, and Summary List of Bills for January 2025 and February 2025 as presented. All members present voting aye, motion carried.

Financial Report- Fox presented the Financial Report. Fox stated that we were 42% through the budget. He stated the income was slightly below target but expects that to increase with warmer seasons approaching. He also stated that there will be two CD's maturing this month. After some discussion, a motion was made by Hartogh and second by Geerts to approve the Financial Report. All members present voting aye, motion carried.

Discussion/Decision regarding raising prices on semi tires to \$20- Fox stated that the current price for semi tires was \$15 each and recommended to increase the fee to \$20 each, due to the high cost of tire disposal. After some discussion, a motion was made by Keifer and second by O'Connell to set the price for semi tire disposal to \$20 each. All members present voting aye, motion carried.

Discussion/Decision regarding raising out of Area Typical Waste to \$100 per ton and out of Area Special Waste to \$125 per ton- After some discussion, a motion was made by Geerts and second by Keifer to raise the out of area typical waste to \$100 per ton and out of area special waste to \$125 per ton. All members present voting aye, motion carried.

There being no further items requiring board action, the meeting was adjourned at 5:47 p.m. with a motion by Steve Geerts and second by Dennis Keifer. All members present voting aye, motion carried.
